(In Auckland that is ATEED, but we can provide this service nationwide). We can guide you through this process and assist with confirmation of eligibility for your company. The criteria are:

- That you are an employer;
- Have fewer than 50 full time equivalent employees;
- Are registered for GST in New Zealand;
- Are operating in a commercial environment;
- Are a privately owned businesses;
- The business was generally sound prior to the COVID-19 challenge and with the right support should survive to provide jobs and income in the future;
- You do need the financial support from Regional Business Partner Network;
- The COVID-19 crisis is affecting your business.
